Road Foreman Matt Springer reported that in August, 1,460 miles were put on trucks. They used 159 gallons of diesel and 107 gallons of gasoline. There was one weather events and no salt mix was used. They applied no cold patch.

The department hauled 60 tons of 448 asphalt and no limestone. There was one burial and no cremations. They poured no head stone foundations. There were no culvert installations.

Trustee Items:

A resolution to prepare and submit application to participate in the Ohio Public works Commission State Capital Improvement Program and to execute contracts as required for Duck Creek Road. Stratton moved, seconded by Bricker. Voting YES – Bricker, Stratton, Mesler. Resolution adopted.

RESOLUTION 2023-0911-04

A resolution to sign the Memo of Understanding with the Mahoning County Engineer to use the ¼% sales tax money for Duck Creek Road. Bricker moved, seconded by Stratton. Voting YES – Bricker, Stratton, Mesler. Resolution adopted.

Stratton thanked Matt Springer, Adam Corll, and John Calko for their work on the display at the Canfield Fair.

Stratton reported that the property on Diagonal Road will go to online Sheriff's Sale at a date yet to be determined.
